- 2. "Utilizing an array of financial metrics -such as Return on Assets, Return on Equity, Profit Margin, and Net Interest Margin—this study augments traditional indicators with additional covariates like technical, resource, and profit efficiency as captured by the Malmquist Productivity Index." "captured" can be revised to "captured by" for better clarity.
- 3. "These design attributes not only address critical gaps in the extant literature but also significantly enhance the study's generalizability, offering a nuanced, comparative lens through which to understand bank performance across varied economic landscapes." "address" should be changed to "addressing" for smoother flow.
- 4. "This research endeavor seeks to enrich the existing body of scholarship through an extensive, multi-country analysis focused on identifying the principal factors influencing bank performance." "endeavor" could be adjusted to "endeavoring" for parallel structure with the preceding verb "seeks".
- 5. "Panel A presented a dataset with 1,470 observations from 105 banks." "presented" can be changed to "presents" for present tense agreement.
- 6. "Table 4 provides descriptive statistics for a range of variables related to bank performance, including measures of profitability, efficiency, and other operational indicators." "provides" should be changed to "provide" for subject-verb agreement.



- 7. "Table 5 provides an analytical overview of the relationships between various financial and operational variables and serves as a tool for understanding the relationships between various financial and operational variables." The repetition of "relationships between various financial and operational variables" is redundant.
- 8. "NIM" This abbreviation should be defined upon its first use to ensure clarity for readers who may not be familiar with the term.
- 9. "In conclusion, the findings from our lagged approach underscore the dynamic nature of determinants influencing bank performance." - The phrase "In conclusion" suggests the end of the article, but it seems there are still sections remaining. It might be better placed closer to the actual conclusion.

These are just suggestions to enhance clarity, flow and consistency. Overall, the article is well-structured and informative

Redaction improvements:

- 1. "These design attributes not only address critical gaps in the extant literature but also significantly enhance the study's generalizability, offering a nuanced, comparative lens through which to understand bank performance across varied economic landscapes." The phrase "These design attributes not only address critical gaps in the extant literature but also significantly enhance the study's generalizability" should be revised for smoother flow and clarity.
- 2. "Firstly, in contrast to prior research predominantly focused on Western economies, our study offers a nuanced, comparative analysis centered on a diverse range of Asian markets, including global financial hubs like Hong Kong and the UAE, high-growth ASEAN markets such as Malaysia and Vietnam, and South Korea's advanced yet still emerging economy." "Firstly" should be replaced with a more formal transition word.
- 3. "Secondly, the multi-country framework enables a more comprehensive examination of how profitability determinants vary across different banking systems, thus filling a lacuna in the existing literature that often concentrates on more homogeneous settings." "Secondly" can be replaced with a more formal transition word or phrase.
- 4. "Lastly, our research employs sGMM as the econometric framework, providing a more rigorous analytical approach compared to the commonly used OLS models for analyzing dynamic panel data." - Similar to the previous points, "Lastly" could be replaced.
- 5. "The data spans from 2010 to 2022 and includes domestic and foreign banking institutions." This sentence is clear, but it's possible for it to be combined with the previous sentence for smoother flow.
- 6. "To assess which variables drive bank performance, we employ a two-step system GMM approach for its superior statistical consistency and ability to address endogeneity." The phrase "for its superior statistical consistency and ability to address endogeneity" can be placed at the beginning of the sentence for emphasis.
- 7. "To construct a comprehensive framework for assessing bank performance drivers, we amalgamate various metrics spanning intellectual capital, income diversity, and efficiency measures." The term "amalgamate" could be replaced with a clearer word.
- 8. "Table 6 presents the results of an SGMM regression analysis focused on understanding the drivers of bank performance." Consider specifying what SGMM stands for upon its first mention to provide clarity for readers unfamiliar with the term.



- 9. "In light of the empirical results, several hypotheses warrant discussion." This sentence should be more specific about which hypotheses are being referenced.
- 10. "This study, analyzing bank performance through the RBV and Efficiency Theory, reveals a complex, non-linear relationship between a firm's internal resources and financial performance, challenging the consistent applicability of RBV in the banking sector." This sentence is quite long and could be broken down for clarity.

Conclusion

Overall, it is certainly a good article. The topic is interesting, denotes a comfortable previous investigation, and its vocabulary matches the intended audience.
