Responding to these Viva voice questions holds immense importance as it allows the candidate to demonstrate their expertise, depth of knowledge, critical thinking abilities, and ability to articulate their research effectively (Lindsay, 2015). Furthermore, engaging in thoughtful and well-reasoned responses not only showcases the candidate's competence but also enhances their credibility and contributes to the advancement of knowledge in their respective field.

Research has shown that doctoral candidates face challenges in answering Ph.D. Viva Voice questions during open defense. Doctoral candidates are subjected to rigorous examination during their Ph.D. viva voice, which often presents a series of challenges. Firstly, the pressure to demonstrate comprehensive knowledge and expertise in their research area, as well as related fields, is immense. Candidates must showcase intellectual depth and be prepared to defend their work against critical questioning from the examining committee. Secondly, the ability to confidently communicate complex concepts and research findings in a concise and coherent manner, while also being prepared to engage in intellectual debates, can be difficult. Lastly, candidates must remain composed and manage any anxiety or nervousness that may arise during the viva voice (Evans, 2018). These challenges are crucial to the overall evaluation and success of the doctoral candidate's research (Garringer and Hogan, 2018).

Most doctoral candidates fail due to a lack of preparation on how to respond to Ph.D. Viva Voice questions asked by examiners during the open defense day (Chen, 2008 & 2014; van der Heide et al., 2016; Lantsoght, 2021-2023; Jalilifar & Mayahi, 2023). Hence, this paper sets out to examine holistic answers to 20 potential Ph.D. Viva voice questions with reference to a Ph.D. dissertation on "Determinants of Entrepreneurship Sustainable Development in Africa."

2. Narrative Analysis on Ph.D. Dissertation on "Determinants of Entrepreneurship Sustainable Development in Africa"

Q1. Can you start by summarizing your Ph.D. thesis?

Answer1: My Ph.D. thesis, titled "Determinants of Entrepreneurship Sustainable Development in Africa," explores the

Tax evasion and corruption have a negative and significant effect on entrepreneurship sustainable development in Africa. However, two variables, inflation and change in government policy, have a negative effect on entrepreneurship sustainable development.

Answer2: I was motivated and inspired to carry out this research due to the significant challenges and opportunities that exist in Africa regarding entrepreneurship and sustainable development.
